SUMMER DUIS: ENJOY YOUR VACATION RESPONSIBLY

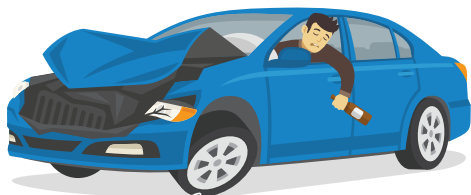

I DONUT KNOW WHAT I'D DO WITHOUT YOU

EASY CAKE-STYLE BITE SIZED HOMEMADE DONUTS

If you want an excuse to indulge in a sweet treat, June 4th is National Donut Day.

INGREDIENTS

1 ¼ cups all-purpose flour
2 tsp baking powder
¼ tsp salt
½ cup buttermilk
¼ cup granulated sugar
2 tbsp melted butter
3-4 cups vegetable oil, for frying

- Pour ½ inch of oil into a large pan or pot and heat to medium. Meanwhile prepare the donut dough.
- In a mixing bowl, whisk together the flour, sugar, baking powder and salt. Separately whisk together the buttermilk and melted butter. Pour buttermilk mixture into the flour mixture. Using a fork, stir in dry ingredients and mix until combined.
- Roll dough into balls (about ½ tablespoon). Once oil is heated, fry the dough balls until golden brown on the bottom. Flip and cook reverse side.
- Carefully remove and place on a lined baking sheet. Roll donuts in sugar and enjoy!
